- Be Alumni of the REACH Program or have similar experience with mentorship within the last five years
- Be willing to commit to the following program expectations:



- Provide virtual mentoring to an assigned Scholar at least once every three months (4 times a year)
- Participate in monthly virtual cohort webinar meetings and Health & Wellness sessions
